▲ Aiding the implementation of the Construction Products Regulation (CPR) through standards

▲ Scope and objectives:

- To develop collaboratively a common understanding of the role of harmonised standards under the CPR, including the role of the different actors;
- To clarify the use of simplified procedures for amending existing mandates and to enhance the process of adding new classes and threshold levels to harmonised standards

▲ Expected outcomes:

- Common understanding of the role of harmonised standards under the CPR;
- Optimization and clarity of processes for the development of European Standards (e.g. Standardization requests changes, request for classes and thresholds);
- Clear guidance for the development of harmonized standards under the CPR;
- Increase understanding, streamline processes and solve current issues.

▲ 5.3.2 Establish and implement the process and timeframe for approval of the introduction of new and/or intermediate classes and thresholds **Completed**

- One single template to request classes and thresholds
- Flowchart provides information on the process;
- Action linked to (5.4.1)

- ▲ 5.4.3 Develop relevant procedures to speed up the amendment of European Standards when changes may be justified (subject to BT s and AG s approval) **Ongoing**

JIS Action 5 – Objectives/Issues/Opportunities



Achievements:

- The most relevant issues and guidance material were identified (5.1.1). The drafting phase is ongoing;
- Flowcharts of the overall process are available;
- Training will start this year.

Issues:

- Slow progress in non-citations;
- Different approach on what should be harmonized in a hEN;
- Links with European Court cases.

▲ Provide high quality standards delivered and referenced in a timely manner

▲ **Scope and objectives:**

▲ Improve timeliness and quality of standards, based on market and public needs, from the preparation of standardization requests to the citation of standards in the OJEU

- Identification of challenges within the entire development cycle
- Ensure involvement of and collaboration among all involved actors

▲ **Expected outcomes:**

- Optimization of processes to meet market and public needs
- Optimization of project planning and management (e.g. working methods, tools)
- Optimization of “interfaces” for all relevant contributors in standards development

▲ Taking the international context of European standardization into account

▲ **Lead:** CEN (with DIN)

Joint Initiative on Standardization – Update on Action 8

Timeline: 2019

▲ Action plan:

- ▲ The subject matter was split in 3+1 Work Items to ensure the integration of all Action 8 members (smaller hierarchy, less coordination complexity)
 - ▲ WI 1 - Standardization requests development process (BSI-EC)
 - ▲ WI 2 - Standards development process (CEN-DIN)
 - ▲ WI 3 - Assessment of candidate harmonized standards and publication of their references in the OJEU (CEN-EC)
 - ▲ WI 4 – Outlook on the digital future of (harmonized) standards (concept)

Joint Initiative on Standardization – Update on Action 8



▲ Last meeting, on 24 January 2018

▲ Significant progress on work items 1, 2 and 3

- ▲ List of actions under WI 1 on the way to be finalized (end of March)
- ▲ New CEN and CENELEC flexible process for standards development is being designed (WI 2) - final approval in October 2018 (BTs)
- ▲ WI 3 New HAS Consultant framework launched by EC ([Presentations event 26 February 2018](#))

▲ Next meeting 6 June 2018:

- ▲ only after the start of the implementation phases under WI 2, following the final approval from CEN and CENELEC BTs



Agreed actions under JIS action 8 WI 1

1. DG GROW to provide to the ESOs and Committee on Standards, and regularly update, a list of potential and draft SReqs including the following detail:
 - EC contact points
 - State of preparation of the SReq
 - Stakeholder groups to be consulted (e.g. committees, working groups)
2. Each draft SReq to be provided with a number and a version number, and to be dated – DG GROW

JIS Action 8 – WI 1 Stand. Requests development process II



Agreed actions under JIS action 8 WI 1

3. Each draft SReq to be accompanied by a table of stakeholder comments and EC responses, including changes made during the ISC (service not to be identified) – DG GROW
4. The SRAHG process to be reviewed for effectiveness and stakeholder involvement - CEN and CENELEC (CCMC and BTs)

Other actions under JIS action 8 WI 1 are still under discussion with DG Grow

JIS Action 8 – WI 2 Flexible Standards development process



- ▲ The new process under development aims at optimizing the use of the 26 months timeframe
- ▲ Time allocated to the Technical Committee work is considered as a pool of 68 weeks (16 months)¹, that can be FLEXIBLY used by the TCs
- ▲ More effective usage of the development time is a driver for better enquiry drafts, increasing the possibility to skip the formal vote



- ▲ This would enable a significant REDUCTION of the development time!!!

¹) This includes drafting of prEN, comment handling after enquiry and drafting of FprEN

JIS Action 8 - proposal WI 2: Roadmap



- CEN and CENELEC BTs have approved the principles of the flexible development

- Milestone of the implementation plan were presented to the Common session of BTs in February 2018:
 - 2018/05/30 – Common session of CEN BT and CLC BT for decisions on operational aspects of NWI
 - 2018/10/10 – Common session of CEN BT and CLC BT for the final approval of the whole process

- The new process will be applied as of 1 January 2019

JIS Action 8 – WI 3 Assessment of (draft) harmonized standards and Publication in the OJEU I



WI 3 to take stock of new HAS-Consultants framework:

- ▲ EC presented the new HAS framework on 26 February that will enter into force in April 2018
- ▲ Collaboration under the new HAS framework between the ESOs, the EC and the contractor EY is starting up
- ▲ CEN and CENELEC are integrating the standards development process and the new assessment process in consultation with the EC and the contractor
 - ▲ Legal and copyright aspects
 - ▲ Data and document exchange (also with ISO and IEC)
 - ▲ Aligning workflows in the different organizations

JIS Action 8 – WI 3 Assessment of (draft) harmonized standards and Publication in the OJEU II



- ▲ ESOs are systematically offering standards according to the new process as agreed in the action plan on structural solutions to decrease the stock of non-cited harmonised standards for
- ▲ In the meantime ESOs and the EC are finding ways forward to the most common hurdles on the way to citation, e.g. the normative references

WI 4 – Outlook on the digital future of (harmonized) standards

- ▲ Map out all the different initiatives that feed in to Digital Transformation
- ▲ 3 ESO to consider input as relevant for their Digital Transformation Processes
- ▲ Further develop current document

Timeline: 2018 and beyond

Current state of play:

- June 2017 : launch of the execution of Action 1, 4 and 5

Ad hoc group 1 'Awareness raising on services standardization' (Action 1-BSI)

Ad hoc group 2 'Identification of priority sectors' (Actions 4 and 5- UNE)

JIS Action 12 - Development of an awareness raising package (Ad-Hoc Group1)



Kick off meeting: 6 July 2017

Action 1 – Development of an awareness raising package containing targeted information material:

- Gathering existing materials (videos, leaflets, brochures etc),
- Information on existing standards and the types of standards to be developed,
- Collect case studies, success stories.

Deliverable: define a communication package using language tailored to the different types of stakeholders (societal stakeholders, businesses,...)

Status: Communication materials on services standardization are being developed - central 'knowledge hub'

Deadline: April 2018

JIS Action 12 - Identification of priority sectors (Ad-hoc Group 2)



Kick off meeting: 14 June 2017

Action 4 – A first pre-selection of service sectors :

- a mapping of existing national service standards,
- based on the work carried out by National Standards Bodies,
- new trends affecting the service sector (consumer behaviour, digitization, globalization etc)
- screening of existing Technical Committees on product standards
- analysis of the evolution of the supply and demand of services

Action 5 – Application of set of criteria defined within the strategy to a list of service sectors resulting from Action 4 in order to identify sectors for which standards could potentially bring benefits:

- In–depth analysis of the service market,
- A methodology for applying the different criteria.

Deadline: February 2018

JIS Action 12 - Identification of priority sectors (Ad-hoc Group 2)



Actions 4 and 5- Achieved milestones

- Mapping of published service standards (national, European and ISO)
- Survey of technical committees on the 'servitization'
- Methodology applied for the pre-selection of activity sectors (starting point NACE codes)
- **Report:** Five highest scoring **activity sectors identified** :
 1. *Retail trade, except of motor vehicles and motorcycles*
 2. *Scientific research and development*
 3. *Waste collection, treatment and disposal activities; materials recovery*
 4. *Wholesale and retail trade and repair of motor vehicles and motorcycles*
 5. *Motion picture, video and television programme production, sound recording and music publishing activities*

Next step: Initiate a constructive dialogue with the stakeholders in the 5 sectors and emphasis the benefits of service standards for their business!

JIS Action 12 - Service angle in JIS Actions



Ensuring the service angle is taken on board on the following JIS Actions:

- Action 4- Improvement of standardisation awareness in national public authorities
- Action 11 – Pilot Project Increased use of standards in Public Procurement to better implement the public procurement Directives
- Action 14 – Standardisation to support digitisation of European industry

Joint Initiative on Standardization – Update on Action 14



Scope and objectives:

- ▲ Standards' alignment as a powerful and fair lever to complement regulatory convergence and foster the competitiveness of European industry and SMEs in global markets.
- ▲ Improve coordination of efforts between European regulators and other members of the European standardization community in relation to trade & regulatory dialogues and other relevant activities.

Expected outcomes:

- ▲ The European regulatory and standardization model, in particular the concept of common regulatory objectives supported by voluntary standards developed in a transparent and inclusive way (cf. the “New Approach” and NLF-type legislation) is promoted outside Europe, through a collective and coordinated effort of European standardization stakeholders, in the context of international trade negotiations and other relevant channels.

Lead: CENELEC - **Sponsors:** CEN-CENELEC, ETSI, AFNOR, BSI, DIN, SIS, COCIR, ECOS, ORGALIME, SBS, UNE, UNIFE, EC DG GROW

 - Same approach as in CEN/CENELEC/JTC 13 ‘Cybersecurity and data protection’ (adopt international standards as ENs, with additional specific European requirements)
 - Collect relevant national material and initiatives
 - Engage defined structures/communities (national industry platforms and PPPs)

State of play

JIS Action 14 to position itself among the many ongoing initiatives addressing Digital Transformation of industry:

- Multi-Stakeholder Platform (MSP) ICT
- EC Digitising European Industry (DEI) High Level group
- MSP/DEI WG on Digital Industrial Platforms and standardisation
- DE, FR, IT Trilateral discussions to promote digitising manufacturing industry
- PPPs

CEN – CENELEC coordinate response

- CEN and CENELEC to agree on strategic priorities to provide the standardization coordinated response to the different European initiatives to be discussed at Boards (21 March 2018)
- Proposal for a Workshop in 2018 o **focus on the link between standardization, pilot projects, test beds and fields labs.**
