

MEMORANDUM OF UNDERSTANDING
BETWEEN
THE CZECH OFFICE FOR STANDARDS, METROLOGY AND
TESTING
AND
THE MONGOLIAN AGENCY FOR STANDARDIZATION AND
METROLOGY

The Czech Office for Standards, Metrology and Testing (ČNMZ) and the Mongolian Agency for Standardization and Metrology (MASM), hereinafter referred to as "the Participants", individually as "a Participant"

- desiring to develop cooperation in the field of standardization, metrology and conformity assessment based on European and international principles, regulations and standards;
- taking into account the importance of life protection and health and environmental care;
- guided by the economic interests in both states of the Participants;

have reached the following understanding:

Section 1

The Participants in accordance with this Memorandum of Understanding (MoU), within their competence and in accordance with the legislation of their states, express their desire to cooperate in the following areas:

- provision of information on European Union's legislation introduced in the Czech Republic and standards and technical regulations adopted in Mongolia;
- exchange of information on authorized and notified bodies in the Czech Republic and the certification bodies and testing laboratories of Mongolia;
- exchange of information on certification and testing with the aim of ensuring conditions for testing and certification results recognition in accordance with the legislation applicable in states of both Participants;
- conformity assessment with the aim of ensuring that conformity assessment results fulfil the standards required by the legislation applicable in states of both Participants;
- exploitation of opportunities of the Czech authorized bodies in conformity assessment of Mongolian products placed on the single market of the European Union;
- training of specialists of the Participants in professional educational systems related to upgrading skills of these professionals;
- implementation of a collaborative study in the areas of mutual interest;
- exchange of information on harmonization of legislation of their national metrology system;
- exchange of information on using of reference on materials defined composition, properties of substances and materials of data on physical constants and properties of substances and materials;
- exchange of information on recognition of test results according to the agreed term and conditions with the aim of the approval of type verification and calibration of measurement instruments supplied mutually by the Participants.

Section 2

The Participants are intending to promote the cooperation under the Section 1 by the following ways:

- exchange of national legislation, technical regulations and other normative documents;
- preparing of joint projects in case of mutual interest;
- meeting of experts, organizing of training seminars and symposiums;
- exchange of scientists, engineers, technicians and other specialists to carry out joint projects;
- arranging of internships and study visits for experts;
- exchanging of information, opinions, experiences, publications, reports and other fields of knowledge according to the mutual interest.

Section 3

In case of mutual interest the Participants may within their competence and in accordance with the legislation of their states settle on the specification of other individual areas of cooperation.

Section 4

The Participants declare their willingness to bear, in compliance with relevant national laws and regulations, their own costs for the implementation of this Memorandum. Subject to budgetary availability of the Participants does not provide for any obligations of either Participants.

Section 5

Information about the results of the cooperation can be published only in case of reaching of the Participants mutual agreement.

Section 6

This MoU is not an international agreement and it does not establish any rights, commitments or obligations regulated by the international law.

Section 7

None of the provisions of this MoU might be interpreted to prevent a Participant from conducting cooperation with third parties in areas covered by this Memorandum.
