Description of content: Tyre pressure gauges for road motor vehicles are placed on the market and put into use in the Czech Republic as legally controlled measuring instruments following type approval and initial verification pursuant to Act No 505/1990 on metrology, as amended. This legislation contains a national metrological regulation of type approval and verification of these measuring instruments.
7. Objective and rationale, including the nature of urgent problems where applicable: In the Czech Republic, tyre pressure gauges for road motor vehicles are legally controlled measuring instruments that are subject to mandatory type approval and verification.
