Description of content: Class 1 and 2 sound level meters, bandwidth filters and measurement microphones are placed on the market and put into use in the Czech Republic as legally controlled measuring instruments following type approval and initial verification pursuant to Act No 505/1990 on metrology, as amended. This legislation contains national metrological regulation of type approval and verification of these measuring instruments.
7. Objective and rationale, including the nature of urgent problems where applicable: In the Czech Republic, class 1 and 2 sound level meters, bandwidth filters and measurement microphones are legally controlled measuring instruments that are subject to mandatory type approval and verification.
